#### Our business services include:

- Chamber of Commerce and Business Improvement District grants: Spring and summer is a time for renewal and PSEG Long Island has renewed our commitment to supporting outdoor dining and commerce. As you begin or continue to develop outdoor commercial spaces, you may qualify for a PSEG Long Island grant of up to \$5,000 to reimburse the purchase of materials including, but not limited to:
  - Barricades and/or planter style barricades
  - Clothing racks
  - Durable safety materials
  - Limited amount of signage in support of outdoor dining/commerce, specifically to support and encourage participation in business openings. Signage funding is limited to 20% of total grant up to \$1,000
  - o Outdoor seating, tables, patio heaters and lighting

Main Street Revitalization Program: The Main Street Revitalization Program is
designed to encourage economic vitality of a business district and to optimize the use of
existing electric infrastructure. This program offers financial incentive awards for projects
in a local business district that are expected to improve the economic stability and
growth of a municipality.

## Eligible projects may include:

- Interior renovations
- Façade improvements
- Streetscape improvements
- Business District Beautification: In addition to our grants in support of outdoor commerce, PSEG Long Island is proud to offer grants for beautification projects in local business districts. We are offering grants to reimburse outdoor beautification costs of up to \$3,500 for Chambers of Commerce, Business Improvement Districts (BID) and Civic Associations with a 501(c)(3) or 501(c)(6) designation.
- Vacant Space Revival Program: Once approved for the Vacant Space Revival
  Program by PSEG Long Island, incentives will be provided for twelve (12) months and
  will be applied to the new business account as bill credits. Credits will be applied
  monthly, based on the start date of electric service or a mutually agreed upon future start
  date. Incentives will be front-loaded, and decline over the first year of service in order for
  the Applicant to acclimate to standard rates. Incentives will be determined and provided
  as follows:

| Time Frame           | Incentive Award  |
|----------------------|--|
| Bill periods 1 – 3   | 100% of energy delivery charges based on the initial three billing periods |
| Bill periods 4 – 6   | 75% of energy delivery charges based on the previous period's billing      |
| Bill periods 7 – 9   | 50% of energy delivery charges based on the previous period's billing      |
| Bill periods 10 – 12 | 25% of energy delivery charges based on the previous period's billing      |
